SUMMARY ANNUAL REPORT FOR

This is a summary of the annual report of the South Bay Hotel Employees Restaurant Employees Legal Trust Fund, EIN 94-6535777 for the year ended December 31, 2021. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$1,379,767 as of December 31, 2021, compared to \$1,373,268 as of January 1, 2021. During the plan year the plan experienced an increase in its net assets of \$6,499. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$61,805 including employer contributions of \$14,895, realized gains of \$16,928 from the sale of assets and earnings from investments of \$29,982.

Plan expenses were \$55,306. These expenses included \$35,056 in administrative expenses and \$20,250 in benefits paid to participants and beneficiaries. Administrative expenses include administration fees, auditing fees, attorney fees, banking fees and miscellaneous expenses.
